Unfortunately, some of ERG's portfolio and affiliate sites operate in "hot spots" in New York and Florida. We had to act quickly and carefully to move to conducting primarily "remote visits" for brief periods at some of these locations. We have been in constant direct contact with our study sponsors, working together to find alternative approaches to maintain trial participant safety and trial data quality and integrity.

ERG has invested substantial time, training and financial resources to building a solid infrastructure that can easily pivot to working in a remote environment. Our Senior Leadership Team, PIs and Site Directors have done a stellar job accelerating expanded training around each of our technology platforms. All our ERG sites are now trained and currently utilizing our internal system for all *Remote Monitoring Visits*, for which our clients are most grateful.
